January 9, 2024

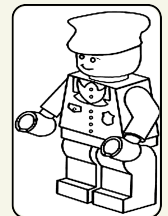

Select Tab: *J6ers Search and Filter*

Pull down menu: Write to J6ers in Jail

Select location where they are jailed: i.e. DC (AKA Gulag--this is the location where we get calls from)

Select the J6 Prisoner you would like to write to.

Guidelines for Correspondence in DC

Envelope

White Envelopes only

Write Senders Address in ink (No stickers)

Write Full Address of Inmate, Inmate Number, Location and Address (about 6 lines) **No Stickers**

Letters

Maximum of 5 pages (white paper only)

Single Sided (you can handwrite or type letter)

Write (or type) Name and Inmate Number on top of each page

Write (or type) Return Address (if you want to receive mail back)

Correspondence will be photocopied and delivered to the inmate.

They will not receive the actual letter.

Cards and Post Cards

You can send **Cards** but the DC Jail will photocopy the card.

Inmates will not receive the actual card.

Write the Inmates Name and Number on card.

Do Not send photo inside the letters. **Do Not** put any stickers on the pages.

If you type a letter you can insert a photo on the typewritten page.

Books and Subscriptions

Books and Subscriptions MUST come from the Vendor Directly (i.e. Amazon)

Books MUST be Paperback. NO Hardcover books are permitted.

Guidelines for Letter in Federal Bureau of Prisons (BOP) - All other Locations

Same Guidelines as above except for Cards. **No Cards** and **No Books** are permitted for inmates in the BOP.

The Letter to the Editor "An Eye For An Eye" was printed the first week of January 2024 in all the newspapers as well as the Sentinel. Iggy is reading it with me. I was going to read it at the January 2024 Jail Board Meeting, but we wanted to give the new Superintendent some 'space' and time to make improvements with the jail. I am sure she and others will see this in the papers. The Letter to the Editor coincides with Martin Luther King Day and so I thought it was appropriate.

LETTER TO THE EDITOR

Dear Editor,
An Eye For An Eye
The Jail Board Members of Northern Neck Regional Jail (the Over site Committee) took an Oath to Defend the Constitution. Well I took that Oath also. I cannot stand by and do nothing knowing the truth of what is going on in this jail. My hands are tied to do anything more than I am doing, writing letters and voicing my concerns.
Martin Luther King, Jr. said, "That old law about 'an eye for an eye' leaves everybody blind. The time is always right to do the right thing."
I have been going to NNRF's monthly Board Meetings every month for nearly 2 years now and holding vigils outside the jail every Friday night for just over a year. I have been voicing my concerns for the inmates at this jail--alone and mistreatment to the prisoners--and the Jail Board Committee has not taken my concerns seriously.
I do not have the time, see energy to watch any longer. Nothing has been investigated and no changes have been made. We give the Jail Board Members information which they can verify and it is just being pushed aside. It is their duty to question and verify any complaint or issue that is brought before them. Why is this jail so profitable and others are not? It's all about the money! Denying medical treatment to inmates, reducing the heat in the winter and the air conditioning in the summer adds up... doesn't it!
Maybe they think it is 'fun' to show control and power over the weak and to those who cannot fight back? Are these guards and CO's just taking orders or are they experiencing 'Napoleonic syndrome' themselves? Why have these issues not been looked into? Is it Laziness? Turning a cheek to a crime is a crime. We need to question what we have been told.
This quote conveys the importance of focusing on what is morally right. The concept of "an eye for an eye" suggests that punishment should be proportional to the crime committed. What should the punishment be for knowing and not acting--in other words, turning a blind eye.
We must consider the outcome of our actions and the time is always right to do what is just, what is moral, and what is right. A new year is upon us. We have a new Superintendent who CAN make a difference. It is not too late to make a change at this jail. Investigate and make a change.
