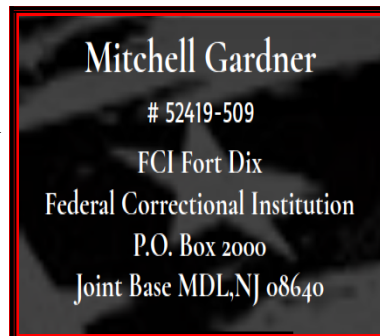

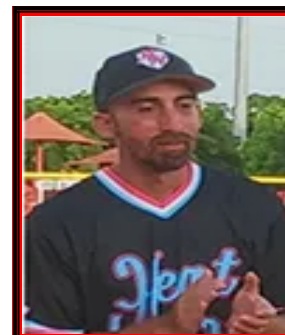

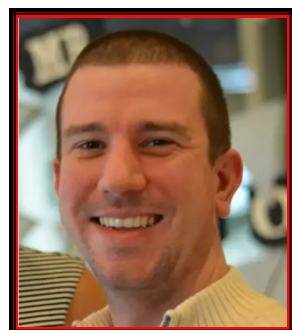
#### Barry Ramey – J6 Commissary and Legal Funds

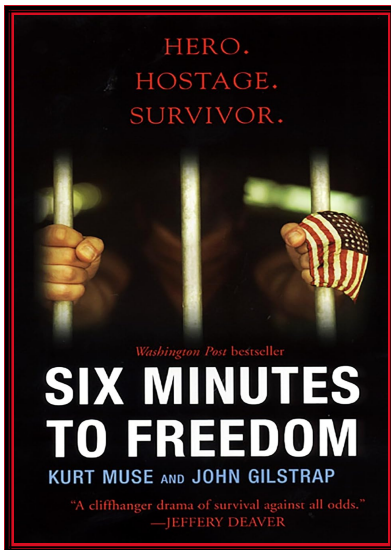

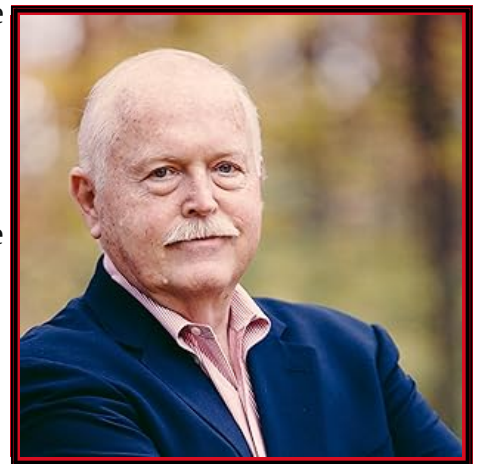
## Prayers

## Kurt Muse -- (Guest Speaker for May 7, 2024 Northern Neck Patriots Meeting)

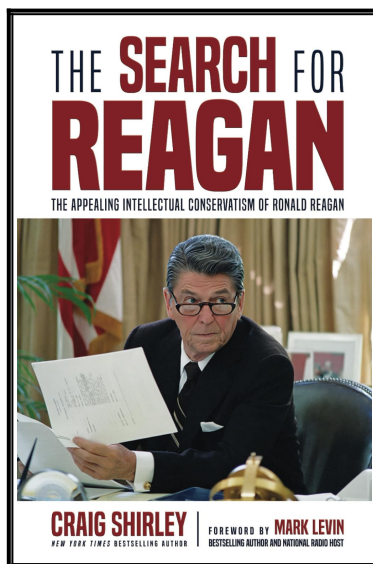
