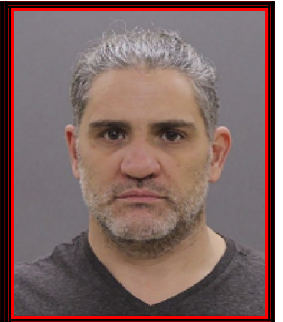

He finally received his test results that were taken last month by the medical staff at Federal Corrections Institution Butner in North Carolina. He was told that he has CANCER. He has a condition called *Barrett's Esophagus* and needs treatment immediately. He has no idea what kind of cancer it is, where it is, how much or what stage it is. 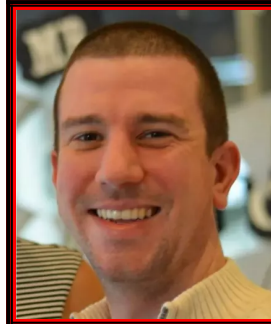

### Christopher Quaglin – Needs help with legal fees

The FBI offered me, “No Charges” if I cooperated with the FBI. I refused. Charges went from 3 to 14 felony charges after being superseded 5 times. I was refused bail time and time again, while I was moved 7-times from jail to jail. I lost close to 200 pounds combined because of an autoimmune disease to wheat and the jails lack of care or understanding. I was thrown in the hole for over 6-months. Hundreds of people called the marshals and federal authorities on my behalf due to ongoing mistreatment and abuse by prison employees. The judge nor the marshals seem to care to help. At this point, I have lost my wife, child, house, everything. I saw something I shouldn't have seen on January 6, 2021, so the feds are trying to keep me quiet by threatening me with over 17 years of prison. **Chris was sentenced to 12 years in prison on May 24, 2024.**

Barry Ramey has run out of funds and could use support to his commissary account to help him get through the next few months. In just over a year he has moved through 12 locations with horrible conditions, lack of medical treatment and suffering from mistreatment at Northern Neck Regional Jail. After sentencing he was moved to Petersburg solitary confinement where he was medically

## **Miracles do Happen**

Thank you for praying. God heard each of you. **Jonathan Munaf**o called on May 24 during our vigil in DC. He is safe and is in doing very well, spiritually, emotionally and physically. He said that he will be released from the BOP in the coming weeks/month. This would be almost one year earlier than his scheduled June 22, 2025 release date. We don't know the reason for the change, but we will update you when he is able to discuss.

## **Brandon Fellows Released from Prison**

Brandon was in NNRJ for about 2 months then was transferred to the DC Gulag. Brandon was just released on May 20<sup>th</sup> and is waiting for the court to approve a location for him to go. He submitted his choice of where he would like to go, but it was rejected. Now he has to wait 30 days to re-submit his housing location. During this period he needs to stay in DC during this probation period so he is staying at the Eagles Nest with Tammy Jackson, Nicole Reffit, and Micki Witthoeft.
