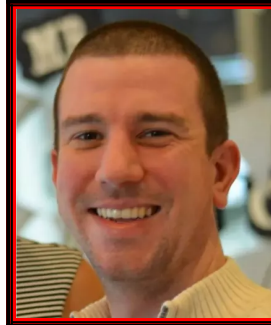

## Christopher Quaglin – Needs help with legal fees

The FBI offered me, “No Charges” if I cooperated with the FBI. I refused. Charges went from 3 to 14 felony charges after being superseded 5 times. I was refused bail time and time again, while I was moved 7-times from jail to jail. I lost close to 200 pounds combined because of an autoimmune disease to wheat and the jails lack of care or understanding. I was thrown in the hole for over 6-months. Hundreds of people called the marshals and federal authorities on my behalf due to ongoing mistreatment and abuse by prison employees. The judge nor the marshals seem to care to help. At this point, I have lost my wife, child, house, everything. I saw something I shouldn't have seen on January 6, 2021, so the feds are trying to keep me quiet by threatening me with over 17 years of prison. **Chris was sentenced to 12 years in prison on May 24, 2024.**

## Northern Neck Patriots Go to Washington

On May 24th five members of the Northern Neck Patriots (NNP) journeyed to Washington D.C. for the sentencing of J6 prisoner Chris Quaglin. Christopher Quaglin received a sentence of 12 years along with two years of supervised probation and a \$2,000 fine.

Upon arriving at the D.C Courthouse the members of the NNP were met by J6er Brandon Fellows and Bob Quaglin (Chris' father). Since his release Fellows has been staying with a J6 support group and has been attending congressional hearings with them.

At the hearing with former NAID Director Anthony Fauci Fellows sat directly behind Fauci and, as his facial expression indicates, he was not buying what the Doctor was selling. Almost instantly the video of Fellows mocking Fauci went viral and appeared on the top line of Gateway Pundit as depicted. According to the accompanying article Fellows "stole the show" with his mugging.

After the hearing Fellows, along with the members of the NNP, attended the nightly vigil at the D.C. Jail that is conducted by Micki Witthoef and her J6 support group called 4Ashli. Micki is the mother of Ashli Babbitt the Air Force veteran who was murdered in cold blood by Capitol Police Officer Michael Byrd on 1/6/21. Byrd was never charged or even questioned. He was, in fact, promoted. All of this is despite Byrd's troubling past including leaving a loaded sidearm in a public bathroom, shooting into an occupied vehicle and failing to adhere to police standards.
