

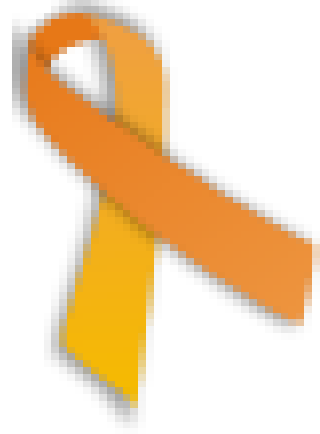

## Rebecca Lavrenz Praying (Great) Grandma

Rebecca Lavrenz, a 72 year old great-grandma was praying at the Capitol on January 6th, and was wrapped up in the crowd that entered in the building that day, most of them through doors held open by Capitol police officers. For this she has been sentenced to 12 months of probation, 6 months of it on house arrest with her internet use being restricted, and a fine in the amount of \$103,000.

## 20 Year Sentence

According to Judicial watch the U.S. District Court Judge Ana C. Reyes gave the government one month to reply to 4 of the 7 counts in the lawsuit. The counts awaiting a reply include wrongful death, negligence, and assault and battery. These counts are all against Michael Byrd.

The judge is also willing to hear arguments for moving the case back to San Diego where Ashli lived, and where her family including her husband live. A San Diego court decided to send the case to Washington D.C. where jury bias has been proven by several people.
