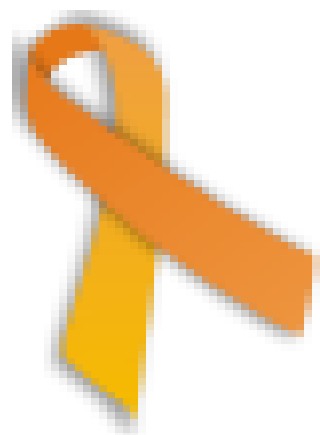

## Nicole Reffitt On Government Persecution

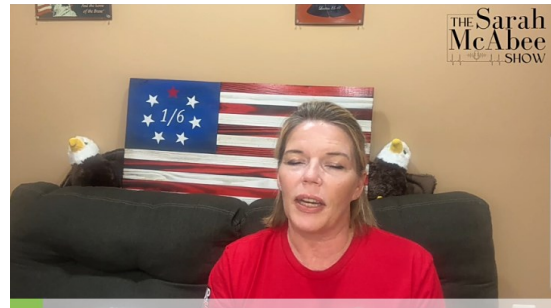
Nicole Reffitt, wife of Guy Reffitt, was the first family to endure a jury trial in Washington D.C. for January 6th charges. In her appearance on the Sarah McAbee Show (pictured right) she explains what she and her family have endured during this persecution.

She speaks of how her husband was made known to authorities by their son, and how he met with the FBI on January 6th while Guy was in Washington D.C. Guy never entered the Capitol building and he was not charged with (or accused of) assault. Guy was charged with the obstruction charge and his son had everything in the house recorded for the FBI to use against his father.

Nicole tells of how the FBI came in a predawn raid for her husband and traumatized her two girls, one of which experienced the flash bangs outside her bedroom window. After the raid Nicole and her girls spent a month sleeping in the living room until they finally moved to Nicole and Guy's bedroom where they would stay for at least two months attempting to recover from the trauma of it all. Nicole also mentions that the house, car, credit cards, and their life was in his name and when the FBI took him from the house everything was taken from them. Their son also left the house at this time due to them realizing what had occurred. The house was foreclosed on, the car repossessed, and the credit cards canceled by the companies. Nicole states there was no concern for how she and her girls would survive.

Guy remains in custody despite the Supreme Court ruling on the Obstruction charge. He was sentenced to 7.5 years. He has served more time than he would have received for the misdemeanor charges. The judge would not release him prior to the SCOTUS ruling on the obstruction charge as she deemed him "a danger to society because it is an election year." Following the SCOTUS ruling the government is claiming he "may have intended to obstruct the proceedings that day."

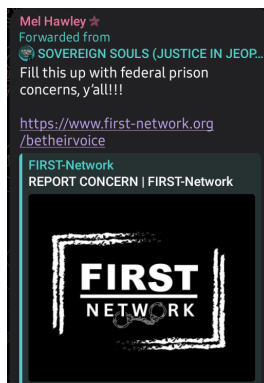
Nicole and Sarah both talk about the "King's Rule," how the prosecutor's office budget grows every year, and how the public defender's office (that citizens have a right to according to the Constitution) diminishes every year. There have been over 1452 arrests (making it the largest prosecution in American History), over 850 of them have been plea deals, over 150 have gone to trial. Nicole and Sarah talk about how there have been arrests from all fifty states, meaning they are arresting your neighbor! And how this morning, approaching 4 years after January 6<sup>th</sup> there are still predawn raids occurring with children having red dots put on them as their parents are ripped from their homes. There have been multiple miscarriages and stories of trauma following these raids that continue to occur today.

## J6 Pipe Bomber According to Dan Bongino

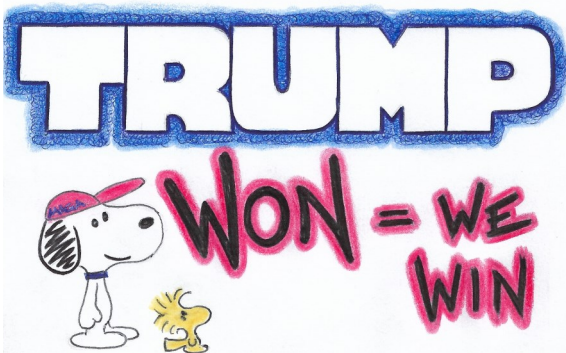
## Prayers For J6ers
