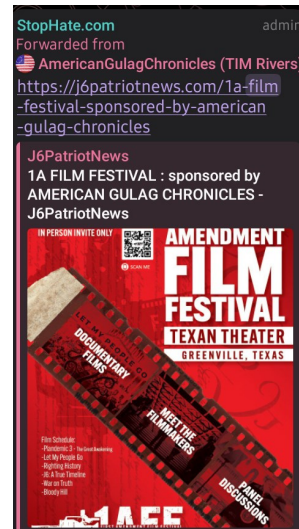

Oath Keepers Attorney Kellye SoRelle Pleads Guilty to J6 'Crimes' – Here's the Real Story Behind Her Horrific Suffering and How the Biden Regime Locked Her Up in a Psych Ward to Prevent Her from Talking

If you witness a crime and are willing to testify to that crime most people in America would think highly of you. Today if you witness a lack of a crime and are willing to testify regarding that you are arrested and charged with crimes. This has been the case for several of the January 6th cases. Kellye SoRelle has endured more than most for the moral and ethical obligation she had as a lawyer.

For two years Kellye was held in a Bureau of Prisons (BOP) mental facility after being deemed incompetent to stand trial. She plead guilty to one felony and one misdemeanor after being held in the facility for two years.

If you were held for two years and treated as though you were crazy, would you plead guilty to something you did not do? What is that right to a speedy trial, how many days? January 6th defendants are not afforded that right, or many others!

Howard Richardson

Out of Prison

Howard Richardson's name has been heard a lot in the January 6th community. The elderly business owner was held in solitary several times and unable to communicate with anyone including his family.

In the latest episode from Justice in Jeopardy you can hear Howard talk of what led him to the capitol on the 6th, what he witnessed that day, what he endured in prison, and what he witnessed on election night 2020 in Pennsylvania. Howard also mentions the loss of his Social Security benefits while incarcerated as "all of his needs were being met." Has anyone received a tray of food in prison recently? While some are serving actual food many do not meet the necessary dietary requirements. We also have several J6er's who do not receive proper health care while incarcerated. So, what "needs were met?"
