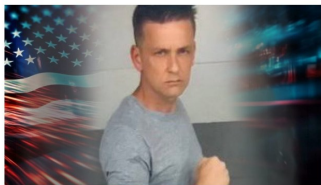

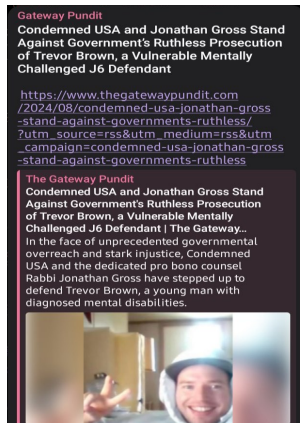

Trevor Brown Condemned USA & John Gross



Trevor Brown is a J6er. He was non violent asking for “peace and unity” that day when he was pushed in front of the crowd in the western tunnel. Trevor is also has mental disabilities that have been confirmed by a competency evaluation ordered by the court. Now, the courts will allow him to plead insanity, that could keep him out of jail, the expert witness will cost him between \$5,000 and \$10,000. This amount may very well be the difference between prison and freedom, but Trevor does not have the money.

Thanks to Trenis Evans of Condemned USA and John Gross this burden has been eased, but not lifted. Evans and Gross both believe that Trevor should be able to have a good defense in spite of not being able to pay. They are simply asking for the help of the American people. 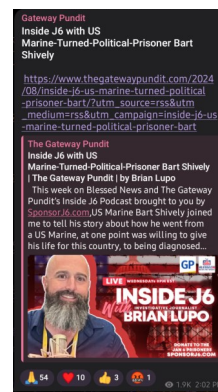
and give him a descent shot of having someone defend him. (Image left taken from The Gateway Pundit)
