Robbed of his rights to vote, watching on the sidelines of this election, another year passes where he's not allowed to (at minimum) receive birthday cards, have visitors or even have a decent meal, much less cake! Weeks have gone by and the mail room is still delaying giving him his mail, so he's cut off from the outside world. We are free as he sits in his cell, and we wish for him to know he's not forgotten. ## Kenneth Bonawitz AKA Coach

Kenneth Bonawitz who is also known as Coach has an interview that was recorded while he was in the DC jail as well as a CondemnedUSA article reposted in hopes of getting attention to his name and his givesendgo account.

Bonawitz explains in the interview that he has worked his entire life and rebuilt his life after a divorce. He also explains plans he was working on for his future when he was detained. While explaining his plans he also explains that his children are starting families, and he does not wish to be a burden on them.

Bonawitz has been detained since January 26, 2023, and made his way through several facilities to the DC jail where most who know him came across him. He has a release date of February 15, 2027. Bonawitz is one of the numerous men who have been unable to work for a living wage the past year of incarceration and has several more to go unless pardons occur as we have heard about.


Bonawitz explains the health issues with eating the food served in most facilities with weight gain being the most common. Usually in federal facilities the food quality is better, but that is not always the case. Even if food is sufficient there are still toiletries and items to help with boredom that need to/could be purchased through commissary.

Also, in the interview Bonawitz mentioned the age at which he planned to retire. Something that will no longer be possible as he will leave FCI Ashland with little to nothing to his name and need to, again, start over. While he does have plans on how to do that, We the People need to Be the People and get him to his release date fed and encouraged that he can and will do this.

## **James Grant** Debut Appearance

James Grant appeared on his first podcast after his release from prison. He appeared on Inside J6

with Brian Lupo. Brian starts every episode with the same question, "What made you go on January 6th?" This led to a conversation about the irregularities in the 2020 election that still have NOT been clarified. There is also conversation about Jamie Raskin's recent comments on Donald Trump being re-elected. James continues with where he was that day and some things that occurred at the first breach that are apparently not common knowledge.

James was a codefendant of Ryan Samsel and was in the vicinity of Ray Epps as he whispered in his ear and the first breach occurred. James walks through some of the events that happened that day and how he was codefendants with 5 men, but there were many who were guilty of the same actions that day.

James also goes into how he was arrested and then the FBI raided his home while he was in custody. This was unnecessary and traumatic to his brother and his parents who were dealing with his dad having his health issues.

James also goes into the conditions and the treatment in the Northern Neck Regional Jail. James touches on his trip through Lewisburg and then made his way to DC.

Talk about what Epps whispered in the ear of Ryan Samsel ear is a conversation that has occurred on multiple platforms. Brian posted an article on the Gateway Pundit this
