Jonathan Mellis Still Enduring

"I am currently incarcerated in Virginia Peninsula Regional Jail. My mother has my phone and is forwarding this text for me." Please share or donate to help me in this new legal fight. Go to www.justiceforj6jonny.com

I WILL NOW EXPLAIN THE LAWFARE BEING USED AGAINST ME IN VIRGINIA. In 2008 I was sentenced by Virginia to 20 years in prison with 10 suspended. It was my first felony. It was a drug charge. I spent 10 years in Virginia prison educating myself and turning my life around. I was released from prison in October 2017 and moved directly to Nashville, TN. I quickly became highly involved in the community, volunteer efforts, and charities. I was released from probation in April 2019 for good behavior. I was told my probation was over. I travelled the country and built a good life. As a service industry worker (bartender/server) I was saving my money to eventually attend school to further my education.

I went to a rally in DC on January 6, 2021. For attempting to save Rosanne Boyland from being killed by police I was incarcerated, spent a year on solitary confinement, denied visitation for 2 years, dealt with abusive guards and gross jail conditions, and was ultimately sentenced to 51 months in Federal prison. I was just released on September 30, 2024.

On November 1, 2024 at 1a.m. my house was raided by the Virginia local police. I was not there, but my friend was. He was alerted by the security cameras and saw a group of people trying to break into the house. He went out to confront these intruders with gun in hand. Luckily he realized they were cops before it got nasty. Apparently there was a warrant for my arrest. I may have been released from probation YEARS ago, but I'm on "lifelong good behavior" by Virginia.

I STILL have 10 years in prison over my head. This is a big surprise to me. I turned myself in to the police on November 2, 2024 at 1am. The Williamsburg, VA Circuit Court Judge has set this matter to be resolved on January 27, 2025. I can receive up to 10 years in prison. Hopefully the Pardon from President Trump will come sooner so this case will be thrown out. This is my situation.

1405 Days of raids of **January 6th** defendants and their families.

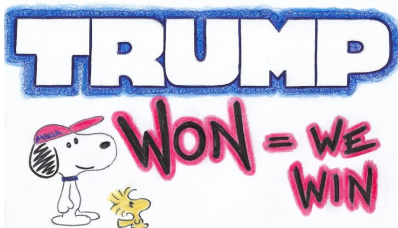

All,

I am in a celebratory mood; this has been a long 4 years. The last year (next week is a year since I left home by myself to go present myself at trial) has been particularly difficult. There have been many, many dark moments. Many moments of severe loneliness, many moments of near hopelessness. There have been also moments where my gratitude has overflowed as my family was taken care of for the last year without me being home. We still have our home, we still have our family, we still have our hope and our faith.

Last night I watched as the entire media establishment sat astonished at the greatest political comeback of any person in probably not just US history, but likely world history. I have felt like a pawn in a larger narrative of a battle between opposing factions who sought power at any cost, including the cost of my freedom, my children's right to draw upon the support of their father, and my wife's right to have a husband. We have endured all of this, because I truly believed that President Elect Donald Trump was a champion for peasants like me; that he understood the doormen, the construction workers, the laborers, the service men and women, all the little people who make up the tapestry of America. I have never shied from any mistakes I have made, or avoided any accountability, but I submit for any reasonable person's consideration that this COST has been excessive. I was so pleased to see that, in my opinion, the true voice of the people was heard loud and clear yesterday. That the faction that sought to censure, prosecute, persecute, exclude, unduly influence, deprive us of our unalienable rights, impose cultural and economic Marxism was soundly repudiated. That there was a ground swell of people who volunteered for this election, lawyers who risked much to take up the cause of simply enforcing the rules, and a ground swell, a 'coalition' of Americans, who put Country before their race, sex, religion or creed to vote in the best interest of themselves and their posterity. As one pundit on TV last night said, "the system self-corrected". When he said that, I nearly wept. Truly the system began the process of self-correction.

I appreciate the support from each of you. This journey is not over, President Trump has long said "promises made, promises kept". He has made some promises, he has spoken his word that he would free people like me. Please, hold him to it, speak up in support of our cause. Please continue to support my family as we navigate what hopefully is a true 'home stretch' where I and the other Sixers can return to our families and loved ones who truly miss us, as we do them.

I thank my wife for enduring this, I thank my wife for avoiding the trap of bitterness and finding meaning and purpose in her Non-Profit, LeftBehindandWithout.org where she lifts the burden of other families who have incarcerated parents. I firmly believe as she has sought to relieve the suffering of others, her burden has been lifted. How we have been provided far thus far is amazing, and I thank each person who contributed in some way, be it a meal, a phone call, financial assistance or even just your prayers, we have felt the impact of each thing and will not soon forget.

Our best days are ahead,
