Barry's fiancée also wrote an article that appeared in The Gateway Pundit about what a halfway house is supposed to be and what Barry is enduring in the halfway house. The

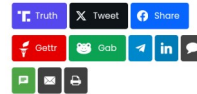
halfway house is supposed to be a stepping stone allowing one to come out of prison and gain employment and start rebuilding life. For Barry this is not the case.

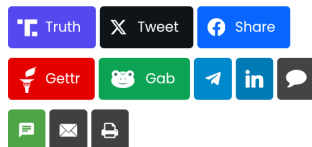

Brecheen wrote a letter to President Trump stating the manner in which his constituent became known as a "violent Jan6er" and the horrible conditions he has endured since his arrest. Brecheen's letter can be read in the article. Benjamin Berlew served this country and is a decorated combat veteran. He is one of 177 veterans who have been charged in the January 6th weaponization of the law against We The People. As far as I know this is the first letter from a representative to anyone in the government.

When Congressman Wittman last attended our local breakfast club he told me he cared about our military. He is well aware he has constituents who have January 6th charges. He has even talked to those he is supposed to represent while they were detained in DC. Many January 6th defendants went through Northern Neck jail (pre-trial) located two blocks down and across the bridge from his office and were said to be treated worse than in DC. Zachary Rehl, among the 177 who served this country and now has January 6th charges sits in Petersburg, VA prison in Wittman's state. To date, I am unaware of anything he has done for any of them, let alone those who are among his constituent's.

Your Assistance Requested

Brian Mock

Many know Brian Mock's name as he wrote a song while in the DC Gulag and his son's had him record it when he was granted bond. That song titled *The Stand* can be found on YouTube. Brian is currently in federal prison serving the remainder of the time he was sentenced to, but should be at a halfway house where he would be able to work and see his sons and his fiancé.

Brian is requesting people contact the following people politely requesting he be placed in a halfway house:

My Case Manager is Mr. Gaede

His supervisor is Mr. Apple

There is a Counselor named Mr. Greinier who got some calls from Larvita

My assigned Counselor is Mr. Meier

I believe the acting Warden is Davis but you may have to check the interweb on that

My current out date is sometime in June/July. However, my FSA projected out date is 4/3/25.

I am supposed to be put in for immediate home confinement once MN Probation approves my transfer. 612-664-5400

DC Probation has to approve releasing me. 202-565-1300

My transfer was signed over a month ago and sent to MN and DC probation. Larvita called and they claimed they never received anything. Mr. Gaede says he did and just resent it today. He claims there is nothing he can do to try to move this along, nobody he can talk to. I did advise him that the MAGA ladies may very well be calling and there's nothing that will stop those zealots. lol. I imagine them to constantly call everyone here and the MN probation, giving my name and number, asking why I am still be held when I should be on home confinement? Why the holdup? Why isn't anyone making this a priority? Is this because I'm a J6er? Is this political?

DC Updates

Many Throughout the Facility

As time drags on inside what once was the J6 pod in DC there are many still going up for sentencings and a lot of anticipation for when we will all know about pardons and what they will look like for them. Please keep them in your prayers.

There are also many like Joshua Atwood who will be missing his first Thanksgiving with his family. This will also be his youngest daughter's first Thanksgiving that he will miss.

Paul Kovacik is one of the many defendants in the DC jail. Due to Aspergers he is unable to work and has a hard time making friends. He has been incarcerated since September and has relied on help from a family member to communicate with others and survive. This has become more difficult as his family member has recently lost employment. Any help is much appreciated.

There are also three J6ers in a pod with general population inmates. That pod is currently without heat in the unit. Michael Bradley, Rockney Earles, and Ryan Wilson are the three J6ers enduring incarceration in freezing conditions. I was told the long johns available are sized small and tear when put on, sweat suits are expensive and out of stock, and blankets are their next best choice. These are also individuals who are missing home and their families. They should not have to endure incarceration ley alone incarceration in a building with no working heat as the weekends are frigid lately. If they are going to have to endure the cold proper blankets and apparel should not only be available for purchase but provided. If you can do anything to assist any of the above-mentioned individuals the assistance is more appreciated than could possibly be known by anyone who has not had to endure it.
