Barry's very first request was to wear his Maga Hat. He proudly put it on as he walked out of the prison with a message for us all... Unbroken and America Strong! As he was on his way out he heard cheers for Trump that could be heard all across the prison compound. 100's of men in the prison yard were making noise, shaking the gates as they celebrated Barry's release from prison and chanted, "Trump! Trump! Trump!"

### Darrell Neely

**Released June 30, 2024 - Re-incarcerated November 4, 2024**

Jenn Baker spoke with Darrell Neely and this is what he said:  
“The Probation Officer violated me right before I was to go on GMR Good Morning Raleigh on November 4. He trumped up charges to violate me because I was heard on radio and seen on Fox taking a political stance on the elections and the IRC and the other homeless shelter in Greensboro NC.

I went through hell there simply because I spoke up and told the truth... I requested to come back to DC to stand with Jake Lang while he is in trial since my Probation Officer would not let me go when I was free. The officer did not like me at all and lied on me. I could not change officers either. I knew he would find me with my name and picture on the hotel I was staying at, but never thought he would blow his cover on the day before I was to go live on TV to support voters choice in electing Trump and all the canvassing I did for Trump.

These people hate and ban and it is real. I chose DC because I want to support Jake Lang so they moved me here but I will return to NC to continue to change hearts and thoughts of others about January 6 and Trump.”

# Artist creates two-story bronze statue of iconic Trump “Fight, Fight, Fight” moment

Ohio artist Alan Cottrill is working on a larger-than-life bronze statue that will honor President-elect Donald Trump's bravery and defiance in the face of a would-be assassin.

The two-story tall statue will capture the iconic moment a bloodied Trump, surrounded by Secret Service agents, rose to his feet in Butler, Pennsylvania, and pumped his fist in the air while telling the crowd, "Fight, fight, fight!"

Cottrill, who created the Thomas Edison statue in Statuary Hall in the U.S. Capitol, was commissioned by crypto investors with the project \$PATRIOT, according to Breitbart News — the outlet said Trump's pro-crypto policies were a motivating factor for the project.

"I've sculpted and cast 400 life-size or larger bronze statues across America and the Patriot Statue is our largest single figure to date," the artist said.

**BREAKING:** President-elect Trump is being honored with a two-story-tall bronze statue, designed to capture his iconic defiant fist pump following the assassination attempt on his life in Butler, Pennsylvania, last July.

The statue is still under construction with the hope of being able to unveil it at Trump's inauguration on January 20, 2025.

"The Patriot Statue of Donald J. Trump was our largest and most controversial undertaking, especially considering the scale and relevance of the event in Butler that took place," Cottrill said.
