Suzanne Monk talks about the J6 Pardons—Stop Worrying!!

On December 5, Suzanne Monk (author of How To Pardon the J6ers: A Comprehensive Strategy Guide for President Donald J. Trump) was at Freedom Corner. This is what she said:

"Justice is Coming. She said she had conversations with many activists like Ann Vandersteel who are doing the work in the front lines and behind the scenes and wanted everyone to know that the J6ers need to be ready to be freed soon. When President Trump takes the oath he is going to mention the J6ers in his inauguration speech. She said that she has kept an up-to-date data base of ALL the information on ALL the J6ers and this was given to General Flynn today. This database also includes EVERY Judge and EVERY prosecuting attorney that was involved in the sentencings of the J6ers so that they can analyze and take care of these Judges and Attorneys who wronged the J6ers. Pam Bondi (Trump's new Attorney General) and the influencers will make sure that justice is served." This is what she told the Boston Globe today.

Update on J6 Children's Christmas Drive

Blanket Pardons for All the J6ers—Pardon of Innocence

Those who were at the Capitol on January 6 were there to protest the certification of what they believed was a stolen 2020 election. Good and patriotic people just wanted to go inside the Capitol to see the "People's House." It didn't mean that they were criminals. They were enraged because of the derelictions of duty on the part of their elected representatives and had legitimate grievances.

The government drew first blood. The majority, if not all, of violence on the part of the protesters was in self defense or in defense of others. The civil and constitutional rights of the people and the protesters were violated by a weaponized and corrupt government. The protesters were fired upon by the police with rubber bullets and tear gas. They were beaten and trampled to death – provoked, causing them to respond defensively. The violence was justified. Those who took part in violence never received due process. Their constitutional rights subverted and withheld in the process. They worked to discredit the people and orchestrated the event, denying a proper certification process. The denial and subversion of the constitutional rights continued through the judicial process to include the physical and psychological torture driving several of the J6 political hostages to take their own lives.

ALL the J6ers need to be pardoned for these reasons:

- The protesters never received due process
- They were set up/entrapped as cover for a larger crime— government actions were clearly deliberate. There would be no arrests had the government not set the stage on purpose.
- Forced to go to trial without all the evidence; exculpatory evidence was deliberately withheld
- · They were over charged and over sentenced
- · They were wrongfully denied bail
- The punishment they received didn't fit the crime
- Denied proper treatment; medical, basic needs
- They were in pretrial detention for 4 years
- · Many were tortured physically and psychologically
- The defendants were denied a jury of their peers
- The offenses on the part of the government against the people cannot heal if this atrocity is not addressed, and addressed well.
