current, upcoming, and during incarceration. While he is free, and at what he now calls home the struggle is overwhelming to say the least. His family lost their home causing the family to live in separate states while he was incarcerated. Now he is out and attempting to put his family back together, but this requires a custody battle for the 50/50 custody he once had of his youngest daughter. Billy is also unable to return to the career he had prior to January 6th due to his political beliefs and an injury sustained while incarcerated. This is just a small piece of his legal and financial struggles currently. More of his struggles are mentioned in the show (pictured above).

Billy also goes into some of what he endured while incarcerated. He speaks of how the people who went and stood on January 6th did so in opposition to a stolen election. He mentions that while he was sitting in the DC gulag, he learned there were ways to get out from behind bars. One could lie about still believing the election was stolen, claim they were deceived by President Trump, or (especially in the Oath Keepers and the Proud Boys) one could turn on fellow defendants. Billy gives details of how he witnessed this occurrence with more than one individual in his time in DC.

Once I got home from jail, my youngest son started really becoming a toddler. I could go out on the back porch, but no further. He would always pull on my hand to go play in the yard and I would always have to say "no. Daddy can't" it broke my heart.

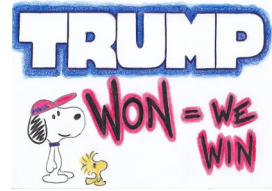
My first day of freedom I loaded him into his car seat and we set off. He said something I couldn't hear so I pulled over and turned down the music. I asked him "What was that?" He said "Thank you Daddy. Thank you Daddy." I feel like he thought I just wouldn't play with him. Or maybe I'm just being extra. But it really lit my heart up. And I promised him that one day we could go see an excavator in real life. I did that the first day.



I want to give God the glory over one more thing. We have a baby due Feb 24. And the way it was looking I was going to be restricted to how long I could be at the hospital for delivery. My wife will be up there for days with the baby and I could only go for a few hours? It was a huge source of stress. But Dad is going to be there from start to finish now. And we thank God for His perfect timing in everything. The new baby will be named Ezra which means "God's faithfulness through a troubled time."

## Northern Neck Stream Hear the J6ers



Friday night, after days of standing in the freezing cold in DC, Tom Jeffries went live and live streamed phone calls of many who were in prison and had not had a public voice since being “shipped up the road” to prison. Chris Quaglin and Tom start with a prayer and the pledge.

Chris walks through what he did endure and still is enduring. He tells some of what he endured up to, through, and after trial. He speaks of his divorce and how it occurred and when he learned it was happening only to later realize that it was really a divorce. There are few who were moved with around as many times as Chris was and with a severe gluten intolerance every move was severe. He states he has lost everything and has not been able to see his son.

Andrew talks of the several medical issues he has, and how it is going to take him some serious time to get all of them taken care of. He details the treatment (or lack of) for his medical issues while incarcerated. Andrew also talks of not being able to sleep, trying to comprehend the feds are not coming to kick his door in again, and having panic attacks.

Curtis speaks of how he was released with nothing, not even an id. He states that Chinese Maga supported him for 3 days until he was able to make his way home. There is a conversation between Tom and Curtis about the different ways people were released from DC too.

John takes the phone and lets Tom know that he appreciates all the Northern Neck Patriots did for them. He explains that he is going to make his way to see his son that he has not seen in 2 years. He states his plans are to get involved in prison and jail reform and that he is likely to go to Texas and rebuild his life.

Robert Turner (Uncle Bob) no known fundraiser

Uncle Bob, as most call him, speaks of being told you all get stuff done because you all stick together and hold these guys accountable.” He also states his plans are to get wealthy and healthy. Tom and Bob both speak on how weird it is to not hear the phone give a 15 minute hang up or a one minute warning before the call hangs up.

Greg Purdy no known fundraiser

Greg has little, but impactful things to say. Among them are the release of the prisoners after President Trump pardoned them being a “new dawn.” This being a “return to common sense.” And, my favorite being, we are “going to make common sense great again.”

## Taylor Johnatakis On Quite Frankly

Taylor Johnatakis wasted no time finding his voice. Before he was home for 48 hours he appeared on the Quite Frankly podcast. They discuss watching Taylor

watching the inauguration and the pardons be granted while Taylor was inside. As the episode continues there is also a conversation about election night and the assassination attempt. At the start of they address the last phone call they had that abruptly ended when he was incarcerated in the DC facility and why it happened.

Taylor goes into his nonviolent assault charges. He discusses what can constitute an assault. His enhancements that led to the 7 year sentence he received was a firearm charge. The prosecutors descried the weapon as a bike rack, not a gun. The obstruction also added to his high sentence.

Among many other points discussed was that the judges, prosecutors, and jurors were likely in DC on January 6th, and due to the mass of people around the courthouse they were likely unable to get home in a timely manner. Would that make a judge, a jury, and the prosecutors biased in anyway against Trump supporters?

Taylor also talks of what is next for him. Like many of his fellow J6ers he is unsure. The career he had is likely over due to his truck and other things being sold. He does mention creating a pod cast. I am sure that will be available soon.
