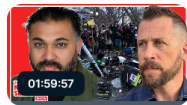
The Voice of the J6er Is Only Getting Louder

You can hear the J6er tell of what they are or have endured in the following places:

Barry Ramey, who still endures a halfway house but was home for most of Christmas Day and spent the day with his fiancé. The wife of Kelly Meggs, Connie, who tells of her continuing struggles. Cowboy Logic has been and continues to be a platform where the J6ers voices can be heard with Dominic Box voicing concerns of being incarcerated with men serving decades as the inauguration and expected clemency and pardons occur for the J6ers on the last episode posted on rumble.

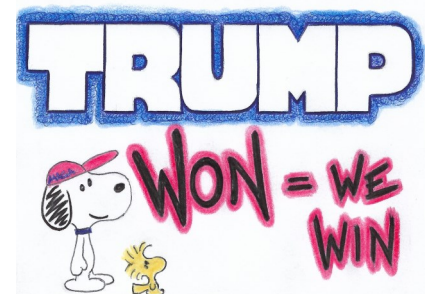
Shawn Bradley Witzemann (@ShawnWitzemann on X) has lost his house and most of his personal belongings due to the prosecution for being present and covering the events of January 6th as a citizen journalist. He has now completed from his supervised release and has taken to social media releasing events occurring on January 6th. His most recent release (pictured left), yesterday January 6th, was titled *Patriots Day* and is a 13-minute video that documents some of what Shawn witnessed while inside of and on his way out of the capitol building that day. Notice police pushing a crowd of people, not escorting them out of the building. Notice there is no violence. Notice who assists the fallen in the crowd. How many times do you hear "I can't breathe" from the crowd?

January 6th Clemency Apparently Being Weighed by Trump

On the 4-year anniversary of January 6th 2021 the certification of President Donald J. Trump had secret service and the national guard present. Why is this something that can be done today and was NOT done in 2021?

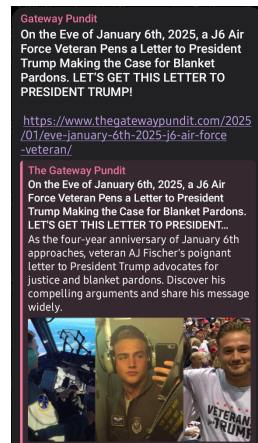
