Both Ben and Elias have charges that would not have been brought against them if there had not been a raid on their homes for January 6ht. Thanks to the tireless work of many lawyers and the CondemnedUSA organization these cases should soon be put behind these men.

Thanks to Condemned Dan Wilson will also not have to report back to prison as he was sup-

posed to do last Thursday. Before learning Dan would not have to report back to prison, he sat down with Jenn Baker for her Flip the Switch w/Jenn podcast.

On the show Dan can talk about his past and how he became an electrician. He tells about going to the capital on January 6th to help protect people. Dan is a III%er and worked with and knows many in the Oath Keeper and Proud

### **Instead of the Loud Story Tellers**"



There were at least a dozen men (and women) who witnessed the death of Rosanne Boyland on January 6th, 2021. Most of them were rounded up, charged, convicted (mostly of assault on an officer), and sent off to prison. That was supposed to keep them from telling her story I think, but there are people out there profiting off the story of Rosanne's death.

In the words of Rosanne's father "the loud story tellers" are publishing books and making money off what they say happened to Rosanne at the capital that day. The problem is Steve Baker, and others can take published books and look at MPD body cam footage as well as Capitol police security footage and find differing stories.

American Shield is supposed to be the autobiography of former U.S. Capitol Police Sgt. Aquilino Gonell. Standing My Ground is Harry Dunn's book that was also proven false. This is not the only place these

lies were sold to the American people. The Oath Keepers trial, the J6 (un) select committee hearing, the DNC convention, and even the Biden and Harris campaign trail all presented and repeated the events of that day, but they were not accurate.

The article on Blaze Media by Steve Baker gives a timeline of the events surrounding Rosanne's death that day according to what Baker has seen on footage and a comparison of that timeline to the books both Dunn and Gonell have published. There is little alignment. Some of events that day were sworn to under oath. Who is guilty of lying under oath?

# Brian Mock On Do Not Talk

Brian Mock writer and singer of The Stand (To My Boys) that he wrote while incarcerated in the "DC Gulag" appears on Charlee Simons Do Not Talk podcast to tell his story. The episode opens with the song and then continues on with Brian giving his experience that January day. Brian explains that he grew up in that city and he had never seen so many people in the city.

Brian continued talking about the peaceful protest and how and when the massive crowd went from peacefully gathered to what many describe today as a riot. That riot started when



police opened fire with rubber bullets on the crowd. Brian explains that he was accused of and charged with assault on an officer. He explains what happened and how prosecutors found "evidence" against him. Then, if the bogus charges were not enough, the enhancements could have kept him incarcerated for 20 years.

Brian walks through both the adventure he is on post pardon and the adventure that was the court proceedings against him. Brian is working on getting Loudermilk to open a real investigation into what happened on January 6th with J6ers and advocates who witnessed and or studied the events of that day. There are things that happened in Brian's court proceedings that will eventually be to the benefit of the many sitting in federal prison. Brian has also been told many stories of odd events occurring on the day of January 6th that need to be brought to the public and our representatives' attention. While there are a handful still incarcerated and fourteen commuted Condemned continues to advocate for them, but this battle has become difficult as many who were supportive during the persecution and prosecution have pulled their funding. The battle is not over, and while it still does include J6ers such as Joe Biggs and has been successful thus far in keeping Dan Wilson from reporting back to prison Condemned is also expanding its legal advocacy. Tina Peters, Jon Woods, and Tyler Burleson are all facing legal issues and are seeking assistance from Condemned. Condemned employs people to assist in their legal advocacy including local Jenn Baker and more recently added as the national spokesperson, Stewart Rhodes.
